



DECISION N° 4

Modification pursuant to the Tariff Treatment for 30 Items including Frozen Tendons of Swine, Mate, Sesamum Seeds and Vegetable Oil of Annex 1 of the Economic Cooperation Agreement between the Republic of China (Taiwan) and the Republic of Paraguay

The Joint Committee of the Economic Cooperation Agreement between the Republic of China (Taiwan) and the Republic of Paraguay ("the Agreement"), pursuant to its powers and according to what is established in Article 6, Article 23 of the Agreement and Decision No.1,

DECIDES:

To modify Annex 1 of the Schedule of the Republic of China (Taiwan) for the Republic of Paraguay of the Agreement, adding 30 products from the Republic of Paraguay including frozen tendons of swine, mate, sesamum seeds and vegetable oil that will enter the Republic of China (Taiwan) to have customs tariffs reduced specific to products of the following tariff lines:

1. Progressively reduce tariffs for the following product with following tariff line:

NOTE: For these imports, they shall be considered as originating in the Republic of Paraguay only in accordance with Article 3(a) of Annex II of the Agreement on Economic Cooperation (ECA) between the Republic of China (Taiwan) and the Republic of Paraguay.

The present decision will enter into force thirty (30) days after notifications between the Republic of China (Taiwan) and the Republic of Paraguay stating that they have completed the necessary legal internal procedures.
