



**DECISION NO. 17**

**Modification pursuant to the Tariff Treatment for 25 Product Items including Prepared and Preserved Meat; Dairy Products; Fruits and Vegetables; and Edible Pork Offal of Annex 3.04 of the Free Trade Agreement between the Republic of China (Taiwan), the Republic of El Salvador and the Republic of Honduras**

The Administrative Commission of the Free Trade Agreement between the Republic of China (Taiwan), the Republic of El Salvador and the Republic of Honduras ("The Agreement"), pursuant to its powers and according to what is established in Article 14.01 (3) (b) (i) (ii), Chapter 8 of Sanitary and Phytosanitary Measures of the Agreement,

**DECIDES:**

To modify Annex 3.04 (1) (f) (g) "Tariff Reduction Schedule" regarding the tariff treatment applied by the Republic of China (Taiwan) to the following list of products originating from the Republic of Honduras, as follows:

Immediately eliminate customs tariffs for products originating from the Republic of Honduras with the following tariff lines:
